**TO BIDDER:** This Addendum is an integral part of the IFB package under consideration by you as a Bidder in connection with the subject matter herein identified. Jefferson County deems all sealed proposals to have been proffered in recognition and consideration of the entire IFB package – **including all addenda**. For purposes of clarification, **receipt of this present Addendum by a Bidder should be evidenced by returning it (signed) as part of the Bidder's sealed proposal**. If the Proposal has already been received by the Jefferson County Drainage District No 6 Purchasing Department, Bidder should return this addendum in a separate sealed envelope, clearly marked with the IFB Name, IFB Number, and Opening Date and Time, as stated above.

**Reason for Issuance of this addendum: Clarification and additional requirements for bid.**

1. The sample contract in the original specifications package states that substantial completion of the project occurs within 90 days and final completion of the project occurs within 60 days. These two numbers are inverted. The correction should read substantial completion within 60days, and final completion within 90 days.
2. Include 3-5 references with names and numbers of companies for whom you have performed this type of work.
3. Please include a brief write up of your approach to performing this job, including the percentage of re-agent you plan to use. Additionally, please include the amount of time your formula takes to firm up before you can get on it to work another section.

4. Once the job begins, the awarded contractor will be responsible for keeping the area dried out.
5. All stumps and other foreign material must be removed by the contractor and thrown out of the mixing area.
6. DD6 currently has a pump on site. DD6 and only DD6 will run the pump at the site as needed to help the contractor dry out the area. This pump will likely not be enough and the contractor may need to provide a well pump of their own. When DD6 runs the DD6 pump, we will also provide the diesel fuel which the pump requires. DD6 will not provide diesel fuel for anything other than the DD6 pump.
7. DD6 will keep a retainage of 10%, and we will allow progress payments every 30 days.
8. DD6 is revising the bid form to include mobilization and demobilization. Mobilization/Demobilization may only be 10% of the bid price. Only 50% of the mobilization/demobilization fee will be paid once mobilization is completed. The remaining 50% will be paid once demobilization is completed.

**Changes to the bid form include Mobilization/Demobilization. Please use the attached revised bid form when filling out your bid.**
